
The Scholarship Program at Dallas Theological Seminary (DTS) provides tuition aid and other financial assistance for students from the United States and around the world. The DTS Scholarship Committee selects qualified candidates for scholarship awards based upon terms established by donors.

Students often face great financial pressure during graduate studies, and many students do not have the support of their families to study God's Word and prepare for ministry. While the seminary strives to maintain low tuition rates, graduate level education is costly. Most students work at least part time while trying to balance work, study, family life, and ministry commitments. When they graduate, their income will likely continue to be modest.

By contributing to the DTS Scholarship Fund, you not only

reduce the financial burden students bear, you also make an investment into the Word of God and lives of pastors, ministry influencers, and missionaries worldwide. Your gift to a new or existing scholarship affords students both support and encouragement to start and finish seminary so they can pursue the ministry to which God

Existing Scholarship Categories at Dallas Theological Seminary

General Scholarship Fund

Nearly all DTS students are financially challenged to find the funds for their education. Friends of DTS who give to this scholarship fund will be supporting a student to help with this challenge. These students could become their own pastor, children's leader, or missionary in the future. Gifts given to the General Scholarship Fund will help students with their expenses without accruing significant long-term financial debt.

Minority Scholarship Fund

DTS makes an effort to provide significant funding each year to qualified American-born minority students. Whether a pastor, writer, or musician, minority student seeks theological training to perfect and sharpen his

or her ministry effectiveness. Your gift to this fund serves to support minority students in need of financial help during their season of training.

International Scholarship Fund

Students from other countries face distinct challenges. Often international students are not permitted to obtain employment in the United States except on the DTS campus. Most cannot work enough hours to offset tuition and living expenses. Supporting international students through this fund allows donors to impact students to reach their countrymen for Christ.

International Leaders Scholarship Program (ILSP)

DTS identifies mature, proven international leaders with financial need and provides full scholarships for tuition, books, living allowance, and health insurance. The goal is to equip strategic leaders with sound biblical, theological, and leadership training so they will exponentially influence pastors, ministry directors, and professors when they return to their home countries. These students sign a commitment to return to their home country or unreached people group after graduation.

Donors may contribute to the above scholarship categories by making outright donations to DTS, designated to the General, Minority, International, or ILSP scholarship funds.

In a country where religious freedoms are not taken for granted, **Dr. Peter Mitskevich** serves as Moscow Theological Seminary's president, senior pastor of Golgatha Baptist Church, and the voice of Chuck Swindoll's Insight for Living radio broadcast in Russia. Since the fall of Communism, Peter Mitskevich has been instrumental as one of

> Russia's rebuilders of Christianity. The legacy and ministry is continuing with Peter's son, Paul, who is currently enrolled at

DTS through the ILSP program. Paul shares, "God has been gracious in providing me the opportunity of getting the best possible seminary training. I am grateful for this opportunity and for His call to do the ministry." He and his wife, Alla, will return to Russia upon completion of his ThM degree. He plans to teach and preach the Bible to help transform the people and life in Russia through the work of the Holy Spirit. TYPES OF NEW FOUNDATION SCHOLARSHIP AGREEMENTS

If you would like to establish a new or unique scholarship through Dallas Seminary

Foundation to support a specific type of student or to honor a church, pastor, mentor, or loved one, you may initiate a named foundation scholarship. The Dallas Seminary Foundation scholarship coordinator works alongside the donor to develop unique scholarship agreements which accomplish the donor's vision. Recipients are selected by the DTS scholarship committee

based on the selected scholarship criteria. There are four types of named scholarships, each defined by the manner and amount of funding.

Current Scholarship

Distributes an annual award using all or a designated portion of the principal and earnings each year

- Minimum gift of \$1,500 to establish; annual commitment of \$1,500 for at least five years
- No fees charged to establish; small fee assessed quarterly to administer a current scholarship

Endowed Scholarship

Distributes an annual award at a rate that is designed to preserve the scholarship fund and its purchasing power in perpetuity.

- Minimum gift of \$25,000; donor may build the fund over time; distribution occurs when fund reaches \$25,000
- No cost to establish; small fee assessed quarterly to cover the cost of investment management and administration
- Principal invested; portion of the investment value is distributed annually (currently 5%)

Term Endowed Scholarship

Distributes a larger amount each year than a pure endowment. The Term Endowed Scholarship can be designed to be depleted over a determined number of years or at a predetermined rate. When the fund declines to less than \$5,000, the remainder of the fund is awarded the next year according to the terms of the agreement.

- Minimum gift of \$10,000
- No cost to establish; small fee assessed quarterly to cover the cost of investment management and administration
- Principal invested; portion of the principal and earnings distributed, allowing the scholarship to be fully distributed based on the term set by the donor
